3. Discussion and Possible Action on the Proposed Land Use Assumptions and Capital Improvements Plan.

John Peterson, HDR Engineer, outlines the proposed service area map which is 694 acres, existing utilities, and proposed improvements, as shown in Exhibits A through E in the handout provided to committee members.

John Peterson, HDR Engineer goes through the Capital Improvements and Land Use Assumption Study packet. He outlines the reason for choosing the target service area, the assumed population growth over the next ten years and service unit projections (ESUs). He explains it is the committee's job to determine what the ESUs will be which can be determined based on

a recommended 300 gallons of water use per day, which, with a ratio of 83% waste water, yields 250 gallons of waste water per day. He determines the residential area of 160 acres to have an ESU of 640 and the light industrial area of 534 acres to have an ESU of 1,602. He also explains that the projected area can be changed by holding a meeting and changing the land use assumption.

John Peterson, HDR Engineer, breaks down the costs for each project, with the total probable cost for all improvements at \$5,959,235.

Michael Stoldt and Committee Members discuss possibilities of saving costs.

Michael Stoldt explains that all the City is issuing right now is what we have already issued. He doesn't plan on issuing the rest of the debt until someone shows interest. He explains the key is to time the debt to when some of the development occurs. He states he has no intention of issuing the debt before it is needed.
