ORDINANCE NO. 4-5-2018

AN ORDINANCE OF THE CITY OF ANGLETON, TEXAS, CANVASSING THE RETURNS AND DELARING THE RESULTS OF THE GENERAL ELECTION HELD ON MAY 5, 2018, FOR THE PURPOSE OF ELECTING THREE (3) COUNCIL PERSONS TO POSITION ONE, POSITION THREE, AND POSITION FIVE, AND OF THE SPECIAL ELECTION HELD MAY 5, 2018, FOR THE PURPOSE OF CONSIDERING AMENDMENTS TO THE CITY CHARTER OF THE CITY OF ANGLETON, TEXAS.

WHEREAS, a general election that was to be held in the City of Angleton, Texas, on May 5, 2018, for the purpose of electing three (3) council persons to Position One, Position Three, and Position Five was cancelled by Ordinance No. 5-02-2018 and were duly elected for purposes of the May 5, 2018 election; and

WHEREAS, a special election was held in the City of Angleton, Texas, on May 5, 2018, for the purpose of considering amendments to the City Charter of the City of Angleton, Texas; and

WHEREAS, the sealed precinct returns for said elections have been delivered to the City Council and have been opened and canvassed as provided by Section 67.004 of the Texas Election Code;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ANGLETON, TEXAS:

Section 1. The tabulation attached hereto as Exhibit A is hereby adopted and declared to be the official result of the general and special elections held by the City of Angleton, Texas, on May 5, 2018.

Section 2. *Severability.* In the event any clause, phrase, provision, sentence or part of this Ordinance or the application of the same to any person or circumstances shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair, or invalidate this Ordinance as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Angleton, Texas, declares that it would have passed each and every part of the same notwithstanding the omission of any part thus declared to be invalid or unconstitutional, or whether there be one or more parts.

Section 3. *Repeal.* All ordinances or parts thereof in conflict with this Ordinance are repealed to the extent of such conflict.

Section 4. *Effective date.* This Ordinance shall become effective immediately upon its adoption.

COMPLIANCE WITH OPEN MEETINGS ACT

It is hereby officially found and determined that the meeting at which this Ordinance was considered was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551 of the Texas Government Code.
