# c. BG Soccer Complex Pavilion

BG Peck pavilion structure has been reviewed but response has not been received to date.

### d. Bates Park Culverts

Angleton Drainage District will not donate culverts for Bates Park but ADD did provide us with an estimate to install a culvert at Bates Park. The Parks Board discussed installing culverts in phases to make purchases affordable within the operational budget.

# e. Parks and Recreation Strategic Plan

Staff is working on a Parks and Recreation Strategic Plan scope of work.

## f. Future Park & Facility Development Ideas

Staff shared several ideas for park development and informed the Parks Board that the city is working with Angleton Drainage District on the Bryan Street Detention plat that may be dedicated for parkland use. Parks Board also discussed partnering with local organizations and businesses for park improvement funding.

Tobacco free park ordinance, Bryan Street Detention plat, park surveillance, Rec Center rental fee assessment, and leash law updates will be discussed at the next meeting.
