Conduct a public hearing to determine if the Chenango Road apartment complex complies with all applicable building, fire, and property maintenance requirements of the Angleton Code of Ordinances and if the complex should be classified as a substandard building, as defined in Code of Ordinances Chapter 5, Article XII, or as a dangerous structure as set out in TLGC Chapter 214 Subchapter A.

Upon a motion by Council Member Tigner and seconded by Council Member Sillavan, Council opened the public hearing. The motion passed on a 5-0 vote. Council Member Wright was off the dais.

The public hearing was conducted and upon a motion by Mayor pro-tem McDaniel and seconded by Council Member Sillavan, Council closed the public hearing. The motion passed on a 5-0 vote. Council Member Wright was off the dais.
