



## Market Days Agreement

Vendor hereby contracts with the City of Angleton for vending space at Angleton Market Days as follows:

1. Vendor agrees to use and pay for booth space as described. Vendor agrees to accept space assigned and not sublet to anyone else.
2. The City of Angleton will not be responsible for any injury which may arise to Vendor, their employees, agents, guests, or customers; or for the loss, theft of or damage to any food, display, merchandise, samples or vehicle from any cause whatsoever while in transit to or from, or while participating in Angleton Market Days. By executing this contract, Vendor agrees absolutely and irrevocably to waive and release any claim it may have against the City of Angleton, their officers, officials, agents or employees.
3. When Acts of God or any other causes not within the control of The City of Angleton make it impossible for the Vendor to occupy the event premises, then in such case The City of Angleton, their officers, officials, agents or employees are jointly released from any and all claims for damages which may arise as a consequence thereof.
4. The Vendor also agrees to the following conditions of this contract:
  - A. All vendors are responsible for the collection and remittance of Texas sales tax.
  - B. Set up shall be completed between 9am and 7pm on Friday before the show. There will be no early admission for set up. Buildings will be locked prior to this time.
  - C. Vendor must conduct themselves in a respectful manner. If a vendor uses abusive or profane language, is disruptive, or fails to cooperate with event staff, they will be removed from the Market Days facilities.
  - D. The City of Angleton has the right to restrict the sale or display of any product it deems objectionable or unacceptable for public display. An objectionable product may include, but is not limited to a product that encourages an illegal activity. If a vendor refuses to remove the product, the City has the right to close down the booth and ban the vendor from future participation in Market Days.
  - E. Vendor agrees to have booth open for business for the entire length of the show. No early tear down allowed. Hours: Saturday 9am to 5pm and Sunday 11am to 4pm.
  - F. The City of Angleton shall be entitled to close any vendor or exhibit for failure of Vendor to perform, observe and comply with any term set forth in this contract.
  - G. Vendor shall not be entitled to a refund or any part of any fee should he/she be unable to participate after acceptance.
  - H. All pertinent laws, ordinances and regulations pertaining to health and public safety shall be strictly observed. See [www.angleton.tx.us](http://www.angleton.tx.us) for code of ordinances for the City of Angleton.
  - I. Vendor will keep their booth space clean and remove trash at the end of the show.
  - J. Vendor will park in designated vendor parking areas only
  - K. Vendor will not adjust music, temperature on thermostats, or prop doors open. With varying comfort levels, we suggest vendors bring a jacket or fan for personal comfort. Please inform a City worker if you need assistance.
