



## **CITY OF ANGLETON NOTICE OF PUBLIC HEARINGS**

The Angleton City Council will conduct a Public Hearing on Tuesday, June 25, 2019 at 6:00 p.m. and on Thursday, June 27, 2019 at 6:00 p.m., at City Hall, located at 120 South Chenango Street, Angleton, Texas. The purpose of each Public Hearing is to receive public comments and testimony regarding the annexation of:

1. The right-of-way of SH 288 north of FM 523 approximately 5.00 miles to the right-of-way of County Road 49; and
2. The right-of-way of County Road 45 between the rights-of-way SH 521 and SH 288B; and
3. The right-of-way of SH 288B between the rights-of-way of County Road 45 and County Road 49; and
4. The right-of-way of CR 49 between the rights-of-way of SH 288 and SH 288B; and
5. The right-of-way of County Road 45 east of the right-of-way of SH 288B a distance of approximately 0.37 miles; and
6. Any property adjoining the aforementioned rights-of-way of SH 288, SH 288B, SH 521, CR 45, and CR 49 where the owners of said properties did not execute a Non-Annexation Agreement with the City after being notified by mail of their eligibility for this Agreement on April 26, 2019 and May 9, 2019.

The proposed Annexation Service Plan will be reviewed by City Council, as will maps showing each property where the owner is eligible to execute a Non-Annexation Agreement. The Public Hearing will allow each owner the opportunity to review their rights and options prior to the July 1, 2019 deadline to execute a Non-Annexation Agreement with the City.

It is the expressed desire of the City that the only properties that are annexed are rights-of-way controlled by TXDOT or Brazoria County and no privately owned property.
