

## SERVICES & RATES

- **Fixed Routes:** Fixed Route transit is a service that picks up and delivers customers at designated bus stops along a set route and according to a set time schedule each day.  
**One-way Trip - Regular \$1. Seniors, students, persons with Disability 50¢. Children 6 and under free.**
- **ADA Para-Transit:** For persons with disability unable to use Fixed Route service and live within three-fourth mile of a Fixed Route bus stop. Threshold-to-threshold next-day service upon availability. For application and questions call 409-945-0820. Call 1-800-266-2320 to schedule ride.  
**One-way Trip - \$2.  
6am to 6pm Mon - Fri; 8am to 6pm Saturday**
- **Demand Response:** Threshold-to-threshold service when available with seven-day advance reservation. Origin must be in Brazoria or Galveston County service areas. Questions and reservations call 1-800-266-2320.  
**One-way Trip - First ten miles \$2. Each additional mile 25¢.  
6am to 6pm Mon - Fri**
- **Veteran's:** Threshold-to-threshold service to Michael E. DeBakey VA Hospital in Houston when available with seven-day advance reservation. Origin must be in Brazoria or Galveston County service areas. Questions and reservations call 1-800-266-2320.  
**One-way Trip - \$3.50.  
6am to 6pm Mon - Fri**
- **Park and Ride:** Facilities to leave vehicle and take a bus from UTMB League City to UTMB Galveston and Fixed Route transfer site at Texas City (GCTD Admin).  
**One-way Trip - Texas City \$2. League City \$4.**

## TITLE VI

Title VI requires that no person in the United States of America shall, on the grounds of race, color, or national origin, be excluded from the participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity receiving federal financial assistance. Any person who believes they have been aggrieved by an unlawful discriminatory practice under Title VI has a right to file a formal complaint with GCTD. Any such complaint must be in writing or by phone and filed with GCTD's Title VI Coordinator within one hundred and eighty (180) days following the date of the alleged discriminatory occurrence. Title VI Discrimination Complaint Forms may be obtained from this office at no cost to the complainant by calling 1-800-266-2320.

El Título VI establece que ninguna persona en los Estados Unidos de América puede ser excluida por motivos de raza, color, o nacionalidad de participar en, ser negado los beneficios de, o ser sujeto de otro modo a discriminación bajo cualquier programa o actividad que reciba asistencia financiera federal. Si usted cree haber sido perjudicado por una práctica discriminatoria e ilegal bajo el Título VI puede presentar una queja formal ante el Centro. Las quejas pueden hacerse por escrito o por teléfono. Estas deben ser presentadas ante el Coordinador del Título VI del Centro dentro de los ciento ochenta (180) días siguientes a la fecha de la ocurrencia discriminatoria alegada. Los Formularios de Queja por Discriminación conforme al Título VI se pueden obtener de esta oficina, sin costo alguno para el reclamante, llamando al 1-800-266-2320.

Scan for League City Park and Ride Schedule

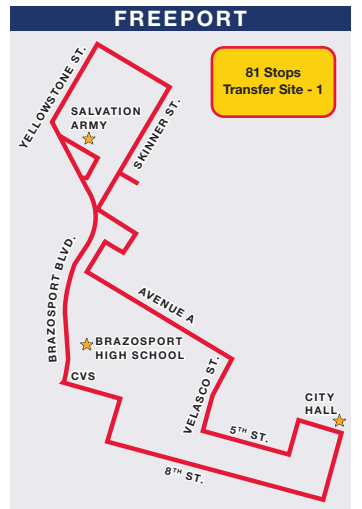
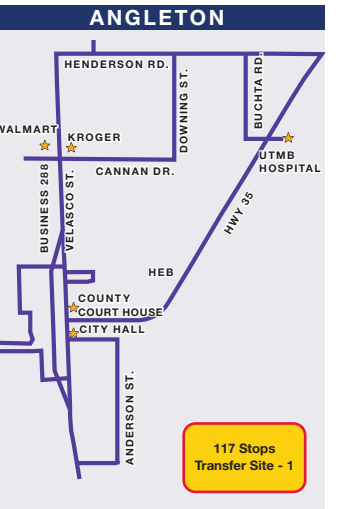

## ENJOY YOUR RIDE

- Free transfer on Fixed Routes. Request Transfer Slip when deboarding first bus. Give to bus operator when boarding next bus. Transferring from Park and Ride to Fixed Route incurs Fixed Route fee.
- Be at bus stop five minutes early and stand in visible location.
- Exact change or fare coupon is required.
- Pull Stop Request cord above window one block from your stop.
- No more than four bags per person.
- Profanity is prohibited.
- Eating, drinking and music without headphones not permitted on buses.
- Use of tobacco products and E-cigs prohibited on buses.
